1. PURPOSE

1.1. To provide direction to Surrey Police Service (SPS) Members when dealing with offenders released with electronic monitoring technology.

2. SCOPE

2.1. This policy applies to all SPS Members.

3. POLICY

3.1. The British Columbia Corrections Branch Central Monitoring Unit (CMU) is the only correctional agency in British Columbia that uses electronic monitoring technology.

3.2. SPS will become involved with electronic monitoring technology if there are reasonable grounds to believe an offender is in breach of a Conditional Sentence Order (CSO), an arrest warrant has been issued for the offender, and/or the offender is believed to be tampering/breaking the electronic monitoring technology.

APPENDIX A: DEFINITIONS

“CSO” means a Conditional Sentence Order, a sentence of incarceration that is served in the community with conditions attached to the sentence.

“Feeney Warrant” means a warrant to enter a dwelling house to arrest a person under sections 529 to 529.5 of the *Criminal Code*.

“GO” means a General Occurrence report.

“Member” means a sworn Police Officer appointed by the Surrey Police Board.

“Parolee” means a person on parole that may be in the community on an escorted or unescorted Temporary Absence, or they may be on conditional release. Parolees may subject to continued monitoring as well as compliance with certain terms and conditions for a specific period or the duration of their conditional release.

“PRIME-BC” means the Police Records Information Management Environment, the provincial police records management system.

“Priority 3” means non-urgent routine service-related calls that do not require a Member’s immediate response, but does require police to attend and investigate.

“SPS” means Surrey Police Service.

“Supervisor” means Sergeant or Staff Sergeant, or Member acting in that role, having the responsibility for first level supervision of Employees under their direction.

“UCR” means Uniform Crime Reporting.
